# Policy Analysis and Forest Governance 101











#### **Topic**

This course introduces the foundations of policy analysis. It will increase learners' understanding of how policy analysis can improve forest governance. It provides tools for analysing laws. It shows what full and effective participation of civil society in legal reforms looks like and discusses how civil society can participate in and influence policy and laws through networks and multistakeholder forums. The course also introduces how policy analysis can be used for advocacy.

#### **Learning objectives**

At the end of the course, you will be able to:

- Define basic concepts about policy analysis for improved forest governance
- Introduce examples of policy analysis tools
- Appreciate the importance of civil society networks and multistakeholder forums and their participation in processes for making policies and laws
- Recognize the role of policy analysis in advocacy

#### **Structure**

This course is self-paced and takes about seven hours to complete.

Introduction	
Session 1 Key concepts on policy analysis for improved forest governance	Provides background of the concepts about policy analysis for forest governance that are needed to understand the course.

Session 2 Policy analysis and tools	Presents examples of policy analysis tools that can be used in analysing the content of laws. Focuses on the Toolkit for Enabling Laws on Community Forestry developed by ClientEarth, but other examples of legal analysis tools are presented as well.
Session 3 Effective participation of civil society in policy and law reform	Looks at what full and effective participation means and the process by which civil society can participate in and influence policy-making through networks and multistakeholder forums.
Session 4 Role of policy analysis in advocacy	Explains how policy analysis can be used for advocacy. Provides practical ways to do different advocacy actions, such as raising awareness and lobbying.

### **Grading system**
